Councillor Burton was in the Chair.

The Chairman opened the meeting.

Ja'Neen Day, CEO of WALC attended the meeting to provide an update and discuss Parish Council issues.

<u>Breach of Injunction</u> – this was discussed in detail.

ACTION:

- (i) Ja'Neen Day to discuss further with CCC.
- (ii) Advise complainants to contact CCC.

Watery Lane closure -

CCC have refused to acknowledge the Parish Council's petition as they state they refuse to accept the change.org petition and expect a new petition to be run from CCC's website. It was agreed that this seriously lacked in transparency, and was an unreasonable request given the work already put into this.

ACTION:

(i) Clerk to chase an update from David Keaney.

CCC Communication -

Ja'Neen had met with officers at CCC last week and talked through various concerns. A further meeting had been arranged.

Parish Boundary -

The draft document on the Boundary Change Consultation stated that the new housing development on land within the Parish would be removed from the Parish. This proposal had been supported by the Parish Council, along with other proposals to make the parish boundary more logical. The southern parish boundary would stop at the A45. However, it was noted that when the final report was published the details were to the contrary.

ACTION:

- (i) Councillor Burton to forward the draft document to Ja'Neen.
- (ii) Ja'Neen to consult the NALC legal team.

659. PUBLIC FORUM

<u>Speeding and volume of cars – Hollyfast Lane</u>

A resident from Hollyfast Lane raised the concern with the volume and speed of traffic using Hollyfast Lane. The road is access to properties only and not a through road. Drivers when challenged were aggressive and unresponsive to the fact that they should not be using the road.

Residents would like the road closed with a physical barrier to prevent motorists abusing the short cut as a rat run.

The road was also a hotspot for fly tipping.

ACTION:

- (i) Due to the status of road already having restrictions (access only road) make a formal request to CCC for the road to be closed.
- (ii) Look at the possibility of s106 funds Chase Rob Back following previous discussion.
- (iii) Request better signage.

Issues at a property on Wall Hill Road

Resident raised the issue that at May's PC meeting, Rob Back had promised to respond to his various requests. No further contact had been received.

The same resident had received a letter from Rob Little (Highways) requesting the removal of his mirrors installed to give visibility when pulling out, which it was claimed had been in position for more than 10 years. It was noted that the offending property had erected a fence on council land which was causing further restricted visibility.

ACTION:

- (i) Invite Rob Little to a future meeting.
- (ii) Resident was advised to seek legal advice.
